Loan Vehicle Hire Terms & Conditions

1. That The Fee Of \$30 For Cars And \$35 For Commercials Be Paid On Return Of The Vehicle Unless Other Arrangements Have Been Made. A Maximum Of Five Days Hire Will Be Charged. After Such Time The Customer Shall Supply Fuel In Order To Complete The Hire Term And Return The Vehicle.
2. That All Running Expenses (including Fuel Within Five Days Hire) Be Supplied By The Company.
3. The Customer Shall Not Lend The Vehicle Or Allow Any Person To Drive The Vehicle, Other Than A Person Authorised In Writing By The Company. The Designated Driver The Customer Or The Person Noted Above As The "driver".
4. The Customer Shall Indemnify The Company For Any Loss Or Damage Caused To Or By The Vehicle Which Occurs Whilst It Is In The Control Of Or Driven By Person(s) Other Than A Person Authorised In Writing By The Company.
5. The Customer Shall Indemnify The Company For Any Loss Or Damage Caused To Or By The Vehicle Which, In The Reasonable Opinion Of The Company, Was Caused Or Contributed To Or By The Vehicle Whilst In The Possession Of The Customer, To The Amount Of The **Current Excess Premium Of \$1000 + Age Excess** Or The Cost Of The Repair Whichever Is The Lower. Such Amount To Be Paid Within 7 Days.
6. The Company Has The Right To Require, In Any Manner And At Any Time, The Immediate Return Of The Vehicle By The Customer And The Customer Shall Return The Vehicle To The Company Or To A Person Nominated By The Company.
7. The Customer Will Advise Immediately Of Any Damage Or Breakdown To The Vehicle.
8. The Customer, While In Possession Of The Vehicle, Will Be Fully Responsible And Liable For Any Traffic/parking Offences Or Any Other Fines Imposed From Time To Time By Local Council And/or Other Controlling Bodies Regulations In Affect In Relation To Any Such Motor Vehicle Offences.
9. Consumption Of Any Alcohol Or Any Drug (unless Prescribed By A Medical Practitioner) Is Not Permitted Whilst Driving Or In Control Of The Vehicle.
10. The Vehicle Will Be Used Within A 50 Kilometre Radius Of The Company Address Unless Otherwise Agreed By The Company.
11. The Vehicle Is Supplied And Shall Be Maintained In A Clean And Tidy Condition. **Absolutely No Smoking Is Allowed In The Loan Cars.** A Charge (payable Within 7 Days) May Be Imposed, At Discretion Of The Company, If The Vehicle Is Returned In Any Unreasonable, Dirty Or Smelly Condition.
